Policy

By agreeing to use our online BrideVue Wedding Planner Consultation Platform, you agree to abide by our terms and conditions. Our terms and conditions can change and alter as needed.

Approval Process

BrideVue holds the right to approve or disapprove your access to the consultation platform for any reason and at any time we deem appropriate in regards to our standards of customer service, professionalism, conduct, and overall effectiveness on our platform. When you first signup to be an online wedding planner consultant on our platform, your access is pending and will be approved or disapproved after we review your submission information.

Independent Clause

As an approved online consultant on our platform, you are agreeing to act solely and independently. We, BrideVue are not your employer and are not accountable for employer responsibilities and duties either directly or indirectly as it relates to taxes, insurance, and employee benefits.

Code of Conduct

- a. By agreeing to these Terms, you're agreeing that, when using our platform, you will follow these rules:
- o i. Don't do anything illegal.
- o ii. Don't engage in any activity that exploits, harms, or threatens to harm children.
- iii. Don't send spam. Spam is unwanted or unsolicited bulk email, postings, contact requests, SMS (text messages), or instant messages.
- iv. Don't publicly display or use the Services to share inappropriate content or material (involving, for example, nudity, bestiality, pornography, offensive language, graphic violence, or criminal activity).

- v. Don't engage in activity that is fraudulent, false or misleading (e.g., asking for money under false pretenses, impersonating someone else, manipulating the Services to increase play count, or affect rankings, ratings, or comments).
- o vi. Don't circumvent any restrictions on access to or availability of the Services.

Payment

To use our online consultation platform you must setup and signup for a PayPal account if you don't already have one. We utilize PayPal when we submit payment to you. We will use the email that you submitted to us on the signup form for PayPal payments. To support our platform and continue to provide and develop the best experience for our customers, we will take 10% of your session rate: \$7.50 from your 30 minute session at \$75/hr or \$14.90 from your 60 minute session at \$149/hr. PayPal may also take a small servicing fee off each transaction. BrideVue will submit payment to your PayPal account within 2-3 days upon receiving credit from the customer.

Cancellation

Either the wedding planner or bride can cancel the consultation appointment by 24 hours before the scheduled session. The bride will be reimbursed for the full amount (minus any PayPal transaction fee). We cannot refund any amount if the session is canceled by the bride within 24 hours before the scheduled session. However, if the wedding planner cancels before or within the 24 hours of the scheduled session, we will reimburse the full amount to the bride (minus any PayPal transaction fee) if a new session has not been rescheduled. BrideVue will automatically email and notify both parties when a consultation session is confirmed or canceled.
